2. You agree to providing no fewer than 2 contact people for the testing phase.
3. You agree to provide detailed reports on your test experience, including but not limited to issues involving:
 - * Installation
 - * OS Performance
 - * System Management
 - utilities work properly, sysman, sysgen, lancp, scacp, msa\$util, sas\$util, backup, etc
 - * Application
 - performance, appearance, behavior, etc.
 - * DCL
 - * Clustering
 - * Networking
 - DHCP, SSH, etc.
 - * Any other problem areas that arise during your tests
4. The test version of OpenVMS 8.4-1H1 is provided "As-Is" for the specific purpose of testing its capabilities within your non-production environment.
5. You agree to provide all of your reports in a timely fashion, and agree to reasonable exchanges of communications regarding the issues you report to the VSI development team.

VSI Obligations

1. VSI shall treat all information communicated to it as confidential and shall only use it for quality checking and improving OpenVMS 8.4-1H1.
2. Tester contact information shall only be used by the VSI development team and not divulged outside this group unless the Tester provides explicit written approval.
3. VSI shall make reasonable efforts to respond to Tester reports and questions.
